
#### **TECHNICAL OUTLOOK**

NIFTY: The negative news flows raised the question mark on bullish sentiments and the critical support zone of 24,780-24,750 has been violated on lower side. The president of United States has announced reciprocal tariffs on countries as the August 1, 2025 deadline came to an end. The administration has stuck to the 25% tariff on India. Although there is no clarity about the penalty but the news provided the momentum to bears and the ongoing correction extended. As we are trading below short term support levels, the cautious stance need to be adopted for the next week and as the medium term trend is still intact this fall should be seen as loss of momentum instead of downtrend. For the week ahead, important support zone is placed in 24,525-24,510 range and if it gets traded on lower side, the fall can extend till 24,380. The upward sloping 100 day moving average and cluster of isolated lows could provide major support to index in 24,400-24,380 range for short term as well as positional traders. On the flip side, the immediate hurdle is placed in 24,780-24,800 range and until it gets traded on higher side, selling at higher levels might not be ruled out.

**BANKNIFTY**: The banking index closed below 20 as well as 50 day moving averages, reflecting the underlying weakness in short term. The support range of 56,000-55,970 was providing cushion to the index on every dip but the violation of support zone has again put the index in sideways zone. The immediate support zone is placed in 55,500-55,460 range and if it gets violated on lower side, the fall is likely to extend till 100 day moving average which is placed at 54,547 level. The bearish view would negate once the 56,540-56,560 range trades on higher side. The decisive breakout above the hurdle range would trigger the fresh buying interest and bulls might take the charge again.

### The option chain reflecting towards certain points

- 1)Even after massive profit booking, there is hardly any unwinding in Put options suggests, fall is likely to arrest at lower levels
- 2)Significant Open interest in almost all immediate call strikes indicating that bulls are weak and profit booking on bounce is likely
- 3)Immediate support as per option data is placed in 24,400-24,380 range.
- 4)Immediate hurdle is placed in 24,800-24,820 range.
- 5) The Put Call Ratio (PCR) at 0.57 indicates, Nifty 50 is moving towards oversold zone.



## **EDUCATION CORNER/ RATIO ANALYSIS**

#### **EARNINGS PER SHARE**

Financial ratio that tells you how much **net income** a company earns **per share** of its outstanding common stock over a given period (usually a quarter or a year). It represents the **portion of a company's profit** allocated to each share, and is one of the most widely followed indicators in **equity valuation and stock performance analysis.** 

EPS = NET PROFIT - PREFERRED DIVIDENDS / WEIGHTED AVERAGE COMMON SHARES OUTSTANDING

#### **Types of EPS:**

**1. Basic EPS:** Simple per-share profit.

#### NET INCOME - PREFERRED DIVIDENDS / WEIGHTED AVERAGE SHARES OUTSTANDING

2. Diluted EPS: Adjusts for potential share dilution (e.g., stock options, convertibles).

# NET INCOME – PREFERRED DIVIDENDS / WEIGHTED AVERAGE SHARES OUTSTANDING + CONVERTIBLE SECURTIES

Example: Net Income = ₹120 crore; Preferred Dividends = ₹20 crore; Shares Outstanding = 25 crore

EPS = 120 - 20 / 25 = ₹ 4.00

This means every share earned ₹4 in profit during the period.

#### **Limitations:**

- Can be manipulated via buybacks.
- Doesn't reflect cash flow or financial health.
- One-time items can distort results.

#### **Why EPS Varies Across Sectors**

- Capital Intensive Sectors (e.g., Oil & Gas, Power): High depreciation and interest costs may reduce EPS.
- Cyclical Sectors (e.g., Auto, Metals): EPS fluctuates with economic cycles and demand.
- Defensive Sectors (e.g., FMCG, Pharma): More stable EPS due to consistent demand.

#### **Conclusion:**

EPS is a powerful metric that provides insight into a company's per-share profitability, but it is best used alongside other financial indicators for a complete evaluation. Strong and consistent EPS growth often signals a fundamentally sound and well-managed company. However, in the presence of convertible securities or potential dilution, **diluted EPS** offers a more accurate and conservative measure of earnings available to shareholders.
