TECHNICAL CHART

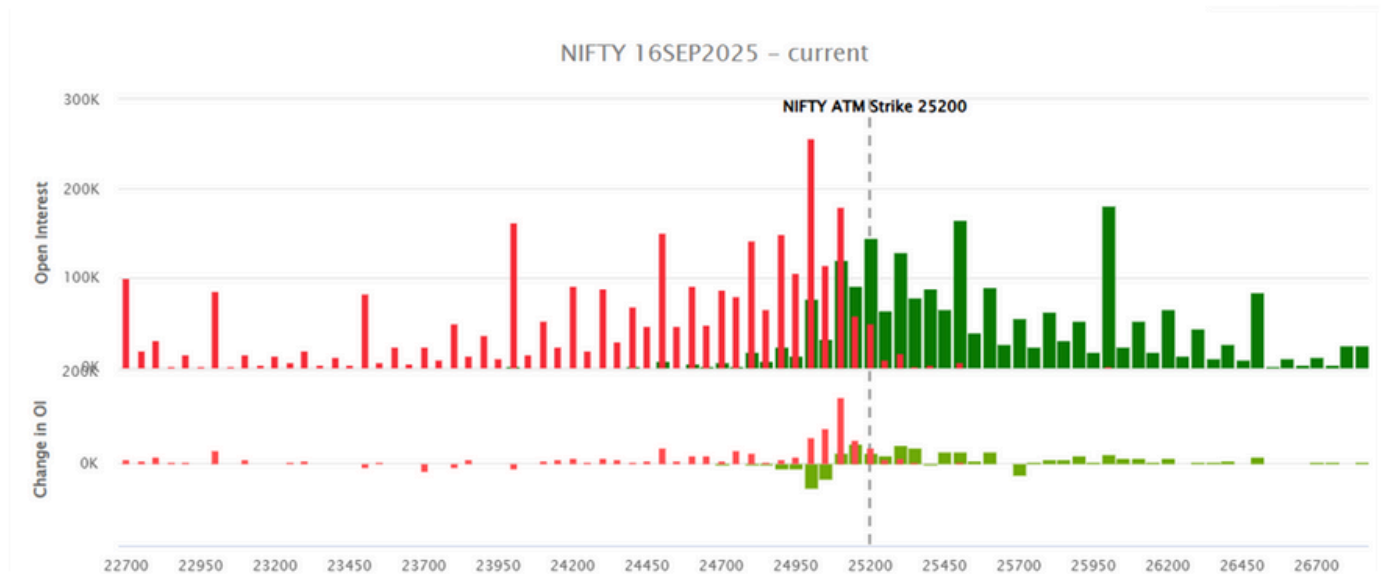


TECHNICAL OUTLOOK

NIFTY: Trading can often be described as battle of psychology. We often witnessed as how the emotions sways the trading decisions and how hope tempts traders to chase the trend. The similar scenario is building up in current market situation. The Nifty50 gradually approaching towards the higher end of the broad trading range and caution bells can be heard on the chart. Keeping the bird's eye view into perspective, index is trading in a broad range of 24,350 to 25,260. We have been repeatedly discussing and sharing from lower end of the range that this market is likely to reward contra trades and bounce back is likely. As expected, we have approached near the hurdle levels. For the upcoming week, the short term traders need to adopt a cautious stance and step aside for time being. The immediate support levels are placed in 24,910-24,890 range and if it gets violated on lower side, correction could extend till 20 DMA, which is placed at 24,811. On the flip side, immediate hurdle is placed in 25,150-25,170 range and the bulls could take the rally towards 25,260 once the hurdle range trades on higher side. The overall setup suggests, for the fresh leg of rally, the index need to trade and close above 25,345 level until then, chances of minor profit booking might not be ruled out.

BANKNIFTY: The uptrend and positive bias is still intact in Bank Nifty but momentum is lacking. The gradual bounce back from the support range has been witnessed in last few trading sessions and overall setup suggests that banking index could take the charge now. The decent base has been formed in 53,590 -53,500 range and until these levels are intact; any minor fall could be a buying opportunity for short term traders. For the immediate short term, the support levels are placed in 54,390-54,360 range and if gets violated on lower side, the fall could extend towards 54,040 and 53,720 levels. On the other hand, hurdle is placed in 55,135-55,160 range and a close above the range could trigger a sharp upside till 55,700 and 56,160 levels. In the short term, private banks are likely to outperform the PSU banks.

The option chain reflecting towards certain points

- 1) The significant open interest of more than 2.56 lakhs in 25,000 strike put option making it strong support range in immediate short term.
- 2) The fresh open interest addition in ITM strikes put options suggest, the room for further upside is still left.
- 3) The immediate hurdle is placed in 25,318-25,330 range.
- 4) The put call ratio (PCR) at 1.33 suggests, Nifty is moving towards overbought zone in immediate short term.

EDUCATION CORNER/ RATIO ANALYSIS

EV / EBITDA RATIO

EV/EBITDA ratio (Enterprise Value to Earnings Before Interest, Taxes, Depreciation, and Amortization) is a widely used **valuation multiple** in equity research, corporate finance, and investment analysis.

- Shows how much investors are willing to pay for a company's operating earnings (EBITDA).
- Unlike P/E ratio, it is **capital structure neutral** (since EV includes both debt & equity).
- Useful for comparing companies across industries or regions with different financing and tax structures.

EV / EBITDA= ENTERPRISE VALUE (EV) / EBITDA

Interpretation:

- **Low EV/EBITDA** → Stock may be undervalued (cheap relative to earnings).
- **High EV/EBITDA** → Stock may be overvalued or have strong growth prospects.
- Typical range:
 1. **5x–10x** is common for many industries.
 2. **High-growth tech/consumer brands** often trade at 15x+.
 3. **Capital-intensive industries** (utilities, manufacturing) usually trade at lower multiples.

Example: Company A: EV = ₹1,000 crore, EBITDA = ₹200 crore

EV/EBITDA = 5×

Company B: EV = ₹2,000 crore, EBITDA = ₹250 crore

EV/EBITDA = 8×

Company A looks cheaper, but further analysis (growth, margins, risks) is needed before concluding.

Limitations:

- EBITDA ignores capex, working capital needs, and debt servicing.
- Can make highly leveraged companies look cheaper than they really are.
- Not ideal for industries where depreciation is a real cost (e.g., airlines, telecom).

Key Insights:

- **High Multiples (Tech, FMCG, Healthcare):** Reflect growth potential, strong brands, or pricing power. Investors pay more per unit of earnings.
- **Moderate Multiples (Retail, Banking):** Balanced mix of growth and stability.
- **Low Multiples (Utilities, Energy, Telecom, Manufacturing):** Indicate slower growth, heavy capital needs, and regulated returns.

EV/EBITDA ratio is useful for comparing companies across industries, but its interpretation depends on sector norms. High multiples often reflect growth and brand strength, while lower multiples indicate capital intensity and slower growth. It works best when used alongside other valuation ratios.
